If you answer 'yes' to **all** of the statements below apply now at grantapproval.co.uk

Eligible businesses are those who:

-  **1** Are based in Lewes
-  **2** Pay business rates (and you are the ratepayer)
-  **3** Have been required to close on 26 December because of tier 4 restrictions and national lockdown restrictions, which began on **05 January 2021**
-  **4** Have been unable to provide in-person customer service from your premises.

£51,000 or above	£13,500*

*The grant value is a combined LRSG 'Closed' Addendum and the Closed Businesses Lockdown payment.

Eligible businesses are those who:

-  **1** Are based in Lewes
-  **2** Pay business rates (and you are the ratepayer) and were trading prior to lockdown
-  **3** Have been financially impacted by Tier 2 restrictions from **2 December 2020**.

If you answer 'yes' to **all** of the statements below apply now at grantapproval.co.uk

Eligible businesses are those who:

-  **1** Are based in Lewes
-  **2** Your business has no non-domestic rating assessment and are not entitled to Local Restriction Support Grants
-  **3** Were open and trading the day before national restrictions were imposed on **26 December 2020**
-  **4** Are now required to close under national restrictions.
