Notice is hereby given that the total payments made by the Council during the financial year 2011/2012 to each member in respect of basic, special responsibility, travelling and subsistence, co-optees' and dependent carers' allowances were as shown on the following sheet:

#### **Notes:**

- 1 Basic Allowance recognises the time devoted by members to their work, including meetings with constituents.
- 2 Special responsibility Allowance recognises the types of special responsibility (e.g. chairmanship of committees and leadership of political groups) for which an additional allowance is payable.
- 3 Travelling and Subsistence Allowances are payable in respect of approved duties.
- 4 Co-optees' Allowance may be paid to persons co-opted onto the Council's committees or sub-committees.
- 5 Dependant Carers' Allowance may be paid to members who incur expenditure for the care of children or other dependants whilst undertaking approved duties.
- 6 The figures relate to the financial year.
