## Multiple work reductions

Where multiple work is covered by more than one of the above categories other than electrical work, then the appropriate charge is calculated by paying the full amount for the most expensive category and only 50% for the other applicable category, based upon the cost of the additional work **provided this work is undertaken at the same time**. Reductions do **not** apply where one of the other categories is electrical work.

Reductions for multiple works assume that work will be carried out at the same time, and that some inspections of the multiple elements of work can be combined. Additional charges may be made for inspections if each element of work is carried out over separate / different time periods.

## Note on Fees

**Full Plans** applications are charged in **two** stages:

1. **Plan check charge** - this is payable immediately after you have submitted your application to us. Payment can be made by credit / debit card by calling us on 01273 471600, option 1, Ext. 8349 – We can also advise you of alternative methods of payment if you prefer. This charge is for us to check and approve your plans.
2. **Inspection charge** - this will be invoiced following commencement of works and after we've made our first site inspection. We will send you a single invoice which covers all site inspections needed for your project.

**Building Notice** applications:

A **single fee** is payable which covers all site inspections needed for your project, this is payable immediately after you have submitted your application to us. Payment can be made by credit / debit card by calling us on 01273 471600, option 1, Ext. 8349 – We can also advise you of alternative methods of payment if you prefer.

## Notes

1. Where an electrical certificate under BS 7671 cannot be provided by a suitably qualified electrician for relevant Part P controlled work, an additional fee as indicated in items 14, 15 or 16 above per application may be charged.
